Pemerintah Republik Indonesia sekaligus menjadi nama pemilik akhir dari Perseroan.

The majority shareholder of the Company is the Government of the Republic of Indonesia, represented by the Republic of Indonesia Ministry of State-Owned Enterprises (SOE), with ownership of 65.05% or 5,834,850,000 shares. The Government of the Republic of Indonesia is also the final owner of the Company.
